1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. ### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Variation : The buyer can increase or decrease the contract quantity up to 50% at any time of the contract. Bidders are bound to accept the revised quantity.

Whenever an additional vehicle required, vehicle of the same specification in the contract shall be provided by the service provider on per day basis on pro-rata rates of the contract. The firm has to provide additional vehicles within an hour after placing demand by the Department. The bills for these additional vehicles provided shall be included in the monthly bills along with regular vehicle bills and the payment will be made accordingly.

In the event of outstation travel, outstation night charges will be paid to the service provider if the duty hours between 10:30 PM to 06:00 AM at outstation location. The same will be paid by the buyer in the monthly bill as per following rates.

Outstation Night Charges = (Monthly Contract Value/30) \* 25% \* No. of Nights

All distances shall be calculated from the reporting point. No payment shall be made for journey from garage to reporting point. Toll Tax and parking charges may be reimbursed to the contractor along with settlement of monthly bills on production of receipts only

DBN shall only be liable to pay the approved hiring charges under the contract. Being the owner of the vehicles, the firm/contractor shall bear all other liabilities. In case of any harm or damage to the vehicle or third parties during the vehicle's deployment with DBN, DBN shall not be held responsible. All liabilities including those arising from accidents and related repair costs, shall be the sole responsibility of the contractor.

To ensure uninterrupted service, the service provider must furnish a replacement vehicle within 30 minutes in the event of a breakdown or the original vehicle being unavailable. This will allow the officer to fulfill their official duties promptly and without inconvenience. The service provider must ensure a qualified substitute driver is available within 30 minutes if the assigned driver is unexpectedly unavailable due to illness or other unforeseen circumstances. Failure to meet this requirement will result in penalties as outlined in the contract.

The working hours of the driver strictly as per requirement of the officer using the vehicle. The Driver should not unreasonably deny assigned duties outside of regular working hours.

The Seller/Service Provider must adhere to all clauses, terms & conditions mentioned in Service Level Agreement

The Service provider should mandatorily provide the vehicle as per model and make of vehicles mentioned in the bid.

The Drivers should be fully conversant with the routes of Delhi NCR They should be well behaved. The ant

ecedents of drivers to be deployed should be properly verified and their details will have to be provided to this office.

Duration of the service contract may be extended upto one year before the initial contract duration (subject to satisfactory performance and mutual consent).

Bid security declaration from bidders in lieu of EMD should be submitted or uploaded with bid documents in GEM.

Net worth of the OEM should be positive as per the last audited financial statement.

Valid documentary should be submitted for past experience.

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

## 2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

## **Disclaimer/अस्वीकरण**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.**

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
