**Subject: Amendment of Agreement No.30-252-5/2020-USF dated 01-11-2021 signed with M/s Reliance Jio Infocom Ltd. (RJIL) regarding provision of 4G based mobile services in identified uncovered villages in two districts of Assam (Karbi Anglong & Dima Hasao).**

In Pursuance of the **clause 4.6 [Extension of the Agreement]** and in view of **clause 4.7 [Modification in terms and Conditions of the Agreement]** & **clause 6.5.3 [Roll Out]** of the agreement dated 01-11-2021, the terms and conditions of the captioned Agreement are hereby further amended to the extent as detailed below: -

The USP shall commission and provide 4G based mobile services from all the infrastructure sites within a period of 18 months from the date of signing of the Agreement.</p>	<p><b>Clause 6.5.2 (Section-VI)</b> The USP shall complete the field survey for at least 30% of sites in the bidding unit in three months from the date of signing of the agreement, at least another 30% of sites in six months from the date of signing of the agreement and the remaining sites in nine months from the date of signing of the agreement to finalize location and type of infrastructure (A&amp;B,) at each site. The USP shall commission and provide 4G based mobile services from all the infrastructure sites within a period of 21 months from the date of signing of the Agreement.</p>
