

Subject: Amendment in terms of conditions of the "Agreement for subsidy support from USO Fund to provide Mobile Services in areas identified by Ministry of Home Affairs, Government of India dated 30.09.2014". (Amendment No .1)

I am directed to convey the approval of Administrator, USOF for amendment to the Agreement dated 30.09.2014 in exercise of powers conferred under clause 2.8.1 of Section II : General Conditions of the Captioned Agreement, specifically the condition of roll-out as below:

- The restoration of 7 (seven) sites and their commissioning in place of damaged towers also to be completed by 30.06.2016 i.e. within 21 months from the date of effect of the agreement.
- All other terms and conditions of the said agreement including clause 4.9.1 pertaining to LD shall remain unchanged.
- Please acknowledge receipt as a token of acceptance.
