No29]	The bidder is free to provide VSAT backhaul at more than 5% sites where ever other backhaul is not available or feasible.
2	32	Section V/ Clause 5.7.7	USP shall convert VSAT sites on microwave/ OFC backhaul within 2 years from the date of commissioning.  [Earlier clarification issued vide Addendum No2 at Sl No. 1 (part-4) & Sl. No30]	Please refer to clarification at S. No. 1 above. Further, in case of availability of other types of backhaul, bidder may convert the site from VSAT as per availability of the backhaul within 2 years or later, as soon as possible.
