1. Section-VII, Financial Conditions 7.4 Bank Guarantees

Amended clause

7.4.1. The USP shall submit a Performance Bank Guarantee (PBG) Administrator USOF in the prescribed pro-forma valid for Two years for each Bidding Unit where the work is awarded to USP, from any scheduled bank in India. The amount of performance bank guarantee shall be equivalent to 3% of total subsidy amount payable to the USP for the entire bidding unit, as specified in tender, for which work has been awarded to the USP. The PBG must be submitted within Fifteen days of issue of Letter of Intent and before signing of the Agreement.

- 2. The Performance Bank Guarantee (PBG) of existing USP shall be revised as per above amended clause. The amount of Performance Bank Guarantee shall be Rs 10,10,67,284/- (Rupee Ten Crore Ten Lakh Sixty-Seven Thousand Two Hundred and Eighty Four only) equivalent to 3% of total subsidy amount payable to the USP.
- 3. M/s Reliance Jio Infocomm Ltd. can submit single consolidated Bank Guarantee(s) for all the Bidding units in place of multiple Bank Guarantees for each bidding unit.
- 4. The amendment comes into effect with immediate effect.

5. This amendment shall be part and parcel of the above-mentioned agreement and other terms and conditions remain unchanged.
