The USP shall commission and provide 4G based mobile services from all the sites within a period of 21 months (15+6) from the date of signing of the Agreement.

#### Clause-2 (Section-I):

This Agreement will remain valid for 21 months (rollout period) + Ten years unless revoked earlier for any reason whatsoever. Date of effect of this Agreement shall be the date of signing of the Agreement.

#### Clause 6.5.2 (Section-VI):

The USP shall complete the field survey for all the sites in six months from the date of signing of the Agreement to finalize location for each site. The USP shall commission and provide 4G based mobile services from all the sites within a period of 27 months (21+6) from the date of signing of the Agreement.

#### Clause-2 (Section-I):

This Agreement will remain valid for 27 months (rollout period) + Ten years unless revoked earlier for any reason whatsoever. Date of effect of this Agreement shall be the date of signing of the Agreement.
