

**Subject: Amendment in Agreement no. USOF/Aspirational Districts/Bihar/2020 dated 22-03-2021 with M/s Bharti Airtel Limited for Provision of 4G based Mobile Services in the identified uncovered villages in Aspirational Districts in the state of Bihar.**

In Pursuance of the Clauses 4.6 [Extension of Agreement], 4.14 [Force Majeure] & 6.5.3 [Roll Out] of the agreement dated 22-03-2021, the terms and conditions of the captioned Agreement are hereby amended to the extent as detailed below: -

Existing Clause (amended vide letter dated 31-05-2021, 04-03-2022 & 18-07-2022)	Amended Clause
<b>Clause 6.5.2 {Section-VI}:</b> The USP shall complete the field survey for all the sites in six months from the date of signing of the Agreement to finalize location for each site. The USP shall commission and provide 4G based mobile services from all the sites within a period of 21 months (15+6) from the date of signing of the Agreement.	<b>Clause 6.5.2 {Section-VI}:</b> The USP shall complete the field survey for all the sites in six months from the date of signing of the Agreement to finalize location for each site. The USP shall commission and provide 4G based mobile services from all the sites within a period of 27 months (21+6) from the date of signing of the Agreement.
<b>Clause-2 (Section-I):</b> This Agreement will remain valid for 21 months (rollout period) + Ten years unless revoked earlier for any reason whatsoever. Date of effect of this Agreement shall be the date of signing of the Agreement.	<b>Clause-2 (Section-I):</b> This Agreement will remain valid for 27 months (rollout period) + Ten years unless revoked earlier for any reason whatsoever. Date of effect of this Agreement shall be the date of signing of the Agreement.
