In Pursuance of the clause 2.8 of Section-II (General Conditions) - Modifications in terms and conditions of Agreement, the terms and conditions of the captioned Agreement is hereby amended with immediate effect to the extent as detailed below:

Clause 4.4.1: BSNL shall set up infrastructure and commission the 4G mobile network and services in the identified areas, within 500 days from the date of Union Cabinet Approval.

Clause 4.4.1: BSNL shall set up infrastructure and commission the 4G mobile network and services in the identified areas, within 500 days from the date of signing of Agreement.

Clause 6.3.1: For tendered items, adjustment of mobilization advance and subsequent payment shall be released circle wise by CCAs as per the tender conditions of BSNL. For nontendered items, adjustment of mobilization advance and subsequent payments shall be on the basis of terms finalized by BSNL.

6.3.1: Clause For tendered items, mobilization advance shall be adjusted circle wise and further fund shall be assigned in BSNL's e- Kuber account (RBI) for payment to vendors under CNA model-I. BSNL will follow CNA Procedure as issued by Department of Expenditure (MoF). BSNL shall submit the claim to circle wise CCAs office for post payment verification. After scrutinization of the claim, CCA will intimate to USOF HQ for recovery/adjustment before next assignment of fund. For non-tendered items, adjustment of mobilization advance and subsequent fund assignment shall be on the basis of terms finalized by BSNL.

2. All other terms and conditions of the Agreement shall remain unchanged.
